

# 22410 STREET SWAY BAR SET 2001-UP LEXUS IS300

- This installation will require:
  - Hydraulic jack, jack stands, torque wrench
  - The following wrenches or sockets: 10mm, 12mm, 14mm
  - Allen wrenches or hex sockets: 5mm
  - Phillips head screwdriver

# INSTALLATION OF HOTCHKIS TUNING FRONT SWAY BAR

- 1) Securely block the rear wheels of the vehicle. Use a jack to raise the front end of the vehicle and support it on jack stands. Observe the stock front sway bar installation for reference.
- 2) Remove the plastic splashguard from under the front of the vehicle. It is held in place by several small screws Use a 10mm socket or wrench to remove the screws. Retain the hardware and splashguard for re-installation.








3) The stock front sway bar should now be exposed. Use a Phillips screwdriver to remove the side splashguards. Remove the retainer screws on each side and retain all hardware and splashguard pieces.











4) Unbolt the stock end link from the sway bar on each side. Use a 14mm wrench and a 5mm Allen wrench to remove the nut from the end link and pull the end link out of the sway bar. Retain the hardware for re-installation.





5) Use a 12mm socket or wrench to loosen and remove the bolts holding the sway bar bushings and bushing retainer brackets in place. The front sway bar should now just drop out. Remove the stock front sway bar. Keep the stock hardware for later re-installation. The stock brackets, bushings, and sway bar will not be re-used.







6) We include heavy duty bushing bracket mounts that replace the OE units. Remove the 3 bolts that secure the OE bracket mount to the frame. (2X) Install the Hotchkis bracket mount onto the frame using the same OE hardware.









7) Use the grease pack provided to apply a thick coat of grease to the inside of the sway bar bushing. Slide the bushing over the sway bar with the split in the bushing towards the rear of the vehicle when installed. Place the new brackets over the bushing. Cover the zerk fittings with the caps attached to the brackets.








8) Lift the Hotchkis sway bar into position the same way the stock sway bar came out. Use the new mounting brackets and stock hardware to secure the new sway bar in place. The end of the bar on the driver's side should slide through the hose as shown.





9) Install the stock end links into the ends of the Hotchkis bar. Note the position of the hole. The hole closest to the end of the bar effectively lengthens the bar for the "softest" stiffness setting. The hole closer to the center of the bar effectively shortens the bar and is the stiffest setting. Tighten the stock nut on the end link with a 5mm Allen wrench and 14mm wrench. Torque the hardware to 25ft/lbs.






10) With the end links tight you can secure the bushing brackets to the new Hotchkis mounts. Use a 14mm socket or wrench to tighten the included M10 hardware. Use the lock washers between the nut and the bracket. The bolt can be installed upward from the bottom.



A properly installed bar will have the middle "hoop" of the bar closest to the ground when looking at it from the front.



1) Re-check all attaching hardware for tightness. Re-install the splashguards on the sides and main splash-pan underneath using the stock hardware. Use a jack to remove the jack stands.

# INSTALLATION OF HOTCHKIS TUNING REAR SWAY BAR

This installation will require:


- Hydraulic jack, jack stands, torque wrench
- The following wrenches or sockets: 12mm, 14mm
- Allen wrenches or hex sockets: 5mm


Securely block the front wheels of the vehicle. Use a jack to raise the rear end of the vehicle and support it on jack stands.

Observe the stock sway bar installation for reference.



Use a 14mm wrench and 5mm Allen wrench to loosen and remove the end links from the sway bar. Use a 12mm socket or wrench to loosen and remove the bolts holding the sway bar bushing brackets. Retain all stock hardware. You may discard the stock sway bar, bushing, and bushing retainer brackets.







The stock sway bar should now be loose and can drop out starting at the driver's side and slide out over the exhaust. The Hotchkis bar will install in the same manner as the stock one.



Use the grease pack provided to apply a thick coat of grease to the inside of the sway bar bushings. Slide the bushings over the bar and place the bushing retainer brackets over the bushings. You might find it easier to install the bushings and brackets after the Hotchkis bar is in place on the vehicle due to exhaust clearance of the bar itself.







Lift the Hotchkis bar into the vehicle over the exhaust in the opposite way in which you removed the stock bar. Slide the frame spacer plate into place for the bushings to rest against as shown. Use the stock hardware to mount the bushing brackets and spacer plate to the sub-frame.






Use a 12mm socket or wrench to tighten the sway bar mounting brackets. Torque the hardware to 30ft/lbs. Use a 14mm wrench and 5mm Allen wrench to tighten the end link sway bar. Torque the end link hardware to 25ft/lbs.



As was shown on the front bar, the stiffness of the rear bar is determined by the hole used with the end link. The hole nearest the ends is the "soft" setting and the hole towards the middle is the "hard" setting.



Re-check the hardware for tightness. Cover the zerk fittings with the caps attached to the brackets. Use the jack to remove the jack stands and you're finished installing your Hotchkis Tuning sway bar set.

IMPORTANT: For regular maintenance the sway bar bushings should be greased at least once a year (15,000 miles) or whenever excessive noise occurs. Use non-lithium based grease only! Lithium grease can wash out with water.

Prepaid, Visa, MasterCard. Net 30 days from invoice date terms are available after credit approval. Accounts with invoices past due will be placed on "Credit Hold". A finance charge of 1.5% per month will also be applied to all past due invoices, not to exceed the maximum charge permitted by law. Accounts are considered paid in full upon Hotchkis Performance Inc.'s receipt of the full invoice amount plus collection fees and expenses incurred, if any. NSF checks stop payment checks, chargebacks on credit cards, etc. are charged a minimum of \$35 fee. No deduction or credit may be taken for any reason unless a credit memo has been issued by Hotchkis Performance Inc. Any unauthorized deduction will automatically put the account on credit hold. Other product special orders require a 50% down payment and are also non-cancelable and non-returnable.

#### DROP SHIPMENTS & REFUSED PACKAGES

Drop shipments are charged a \$30 service charge. A 20% restocking fee and all shipping costs are charged to the ordering party if a package is refused. No international drop shipments.

#### RETURNS

All returns are subject to prior authorization from Hotchkis Performance Inc. Once authorized, a Return Merchandise Authorization (R.M.A) will be issued. All authorized returns must have the R.M.A number on all cartons and shipping documents. Returned product must be shipped prepaid – collect shipments will be refused. Modified or used products are not eligible for return. Returns MUST be made within 90 days of invoice date and are subject to a 20% restocking fee. No returns are accepted after 90 days. Freight charges are not refundable unless the merchandise is defective as determined by Hotchkis Performance Inc. Special orders are not returnable.

## DAMAGED SHIPMENTS / SHORTAGES

All Hotchkis Performance Inc.'s shipments are F.O.B. our factory. Title passes from Hotchkis Performance Inc. to the purchaser at the time is shipment initiated. Claims for Carton shortages and damages must be made against the carrier at the time of delivery. To expedite processing of claims against the carrier, the customer must note damages on the bill of lading at the time of the delivery, and promptly request an inspection by the carrier or its claims agent. If a shortage is found within the shipment, it must be reported to Hotchkis Performance Inc. in writing within five (5) business days of receipt of shipment. Claims need to include the following information order number, invoice number, date of invoice, date of shipment, part number, description and carton count.
